Critically thinking when scheduling appointments given the scenarios needs improvement. There are two factors working against their ability to critically think. One is what they may have experienced clinically in specialty practice vs a general practice (anesthetizing the entire mandible vs quadrant dentistry) and not considering what they learned in class. The other factor is that they rush through their assignments or pick and choose which ones to complete due to this class being offered their last semester while they are in clinical rotations and completing their capstone course.

Combined, 93% (28/30) of the students scored an average of 80% overall.

Students that completed all the assignments performed well and displayed entry level knowledge of dental business office procedures.

In 2019, the assignments were modified to include current business practices. That semester 100% of the students scored 82% or higher overall. In 2020, 4 out of the 5 students performed at 89% or higher overall. While the standard of success was not met in 2020, the faculty feel as though the current assessment tools reflect procedures that are performed in the dental office and no modifications are needed. Students tend to rush through the assignments of this course as it is their last semester and they are in clinical rotations four days a week.
